The non-punitive No Bully System® has created bully-free campuses for over 200,000 students. Incorporated in 2009, No Bully® began in San Francisco in 2003 as a collaboration of educators, psychologists and lawyers committed to preventing the current generation of students from enduring the bullying that they experienced when they were in school. The No Bully System® is a step-by-step process and set of interventions to prevent and stop bullying in schools. It guides school leaders and staff through a series of interventions for responding to bullying and harassment, depending on the severity of the incident. When severe or persistent bullying occurs, teachers facilitate Solution Teams®, where the target's peer group and the bully come together to stop the bullying. The evidence-based approach leverages the empathy**
